- 2. Application fee Rs. 1000/- only (non-refundable).
- 3. Online Application will be opened from 11th November 2023 & 12th November 2023. Timing 10:00 a.m. to 12:00 noon.
- 4. The completed form should be submitted along with necessary documents. Those Forms without the necessary documents will be rejected. No form will be accepted thereafter.
- 5. The Principal reserves all the rights of admission or rejection and is not bound to give any reason for admission or rejection of any candidate. The principal's decision will be final.
- 6. Registration is no guarantee of admission, admission will depend on the availability of seats and merit.
- 7. Timings, the mode of interaction and test will be communicated through SMS on your mobile.
- 8. Parents are strongly urged to try other schools as the number of seats in St. Francis' Convent School, Kankerkhera are limited.
- 9. Any attempt to use friends or influential people in procuring recommendations for admission will lead to disqualification.
- 10. The original Date of Birth certificate of the child should have: Child's name, father's name and mother's name written on it.

# 16. Both parents must be present with the child on the day of interaction with **Principal** as the signatures of both are imperative.
