- 5. The principal reserves all the rights of admission or rejection and is not bound to give any reason for admission or rejection of any candidate. The principal's decision will be final.
- 6. Registration is no guarantee of admission, admission will depend on the availability of seats and merit.
- 7. Timings, the mode of interaction and test will be communicated through SMS on your mobile.
